## Southwest Covenant School Tuition Assistance Acknowledgement

Generous donors have provided SWCS funding to provide tuition assistance to a limited number of our students. The amount we can give varies, dependent on the gifts given, from year to year.

Since there is no assurance, we will have adequate revenues to aid all applicants, please prayerfully consider your family's real need (not just want or convenience) for assistance before applying.

Applications and assistance awards are made on an annual basis. Receipt of assistance in one year is not a guarantee of assistance in future years.

The following requirements must be met in order to receive and retain assistance:

- Demonstrated need
  - Assessed through annual, online application with FACTS and / or interview with Headmaster
- Academic Success
  - Students must maintain a "C" average or higher
- Exemplary behavior
  - Students must not be involved in more than two disciplinary incidents in each semester
- Family involvement
  - Family support of SWCS fundraising events
  - Regular church involvement as well as participation in service/volunteer projects for the school are encouraged
- Meeting financial obligations
  - Families receiving assistance must stay current with agreed to monthly obligations
  - Tuition payments must be received by the 16<sup>th</sup> of each month
  - No returned checks for tuition or any other payments to the school
- Note of appreciation
  - Annually, families receiving assistance should send a note of appreciation that can be shared with those who assisted by March 1<sup>st</sup>
  - Notes should be sent to the business manager and should include information regarding your child(ren)'s progress

In all cases, tuition assistance will be predicated on the availability of funds. Financial need is the primary consideration for assistance. *At no time will students with athletic skill or experience be given preferential treatment for scholarship funds, nor will athletic skill or experience be considered in the evaluation process.* Academic effort and student behavior are considered.

### Failure to meet any of these requirements could result in loss of assistance.
